With 30 years of experience, first as independent stand-alone surveyor, then forming Sea Metria Srl in Genoa in 2003, and working since 2014 with Marine Consulting MC SARL in Monaco, Stefano Ruscitti has successfully managed several large scale projects.

#### **CONSTRUCTION SUPERVISION**

1995-1997 POSILLIPO 87' motoryacht in Sabaudia- Italy (German client)

Contract and specification review. Supervision and management of the project during the construction of the yacht, sea trials, functioning tests and after sales assistance.

1997–1998 BAGLIETTO 36m motoryacht in Varazze- Italy (German client)

This motor yacht had sunk, and an extensive project was commenced to bring the yacht back to the high standard required. The vessel was stripped back to the bare hull and superstructure. After a full survey of the damaged hull areas, the hull and internal structures were repaired and preserved. On completion, the vessel had to be rebuilt, including all interiors and systems. To be able to refit her in time for the coming season, the project involved tight management of the time schedules.

### 1997–2000 CODECASA 49m motoryacht at Amels in Holland (Swiss client)

Two years after her delivery, a refit was carried out at Amels Shipyard, to take care of planned and unplanned maintenance and to upgrade all systems that were not satisfactory to the owner to a higher standard. The most complex operation was the modification of the recycled and fresh air-conditioning system, so as to achieve particularly strict criteria. Noise isolation for all of the guest cabins on the lower deck had to be reviewed, which involved the dismounting of all furniture, the installation of additional insulation material and the final re-installation of all interiors after cutting all edges, so as to match the reduced volume of the single spaces.

Appointed by a German shippard to ensure quality control of materials, finishing and work progress of the Italian subcontractor selected to manufacture the main 800 sqm stairwell interiors, covering four decks.

M/y "Tommy" 53m Benetti built in 1995 (steel/aluminium) (2000-2021) (Portuguese client)

Following a large scale refit in 2000, we acted as technical manager for this 53m Benetti, including all ordinary and extra-ordinary maintenance of the vessel, taking care of all contractual and technical aspects, as well as charter activity and all relations with Flag, Class and Port authorities.

M/y "The One" 71m Lurssen built in 1971 (steel/aluminium) (2003-2004) (Monaco client)

After the initial condition survey was carried out on behalf of the new owner, we were appointed as technical managers for a two-year period until the owner's representative had acquired enough experience to proceed with the technical management on his own.

M/y "Victory" 54m Golden Yachts new built (steel/aluminium) (2008-2015) (Russian client)

In 2008, Sea Metria was appointed by the owner as the technical management company. The principal task was the organisation of an extensive refit program, intended to resolve several constructive defects aboard the vessel.

From the very beginning, Sea Metria also managed the contractual aspects with the involved contractors, and acted as owner's representative in front of all institutional counterparts involved (Flag, ABS).

M/y "Divine" – Columbus 40m Hybrid Sport new built (2015-2017) (Russian client)

Following delivery of the new vessel on behalf of the buyer, Marine Consulting was appointed as technical manager.

M/y "My Secret" 49m Heesen built in 2012 (steel/aluminium) (2018) (Cypriot client)
